Regular Board Meeting May 2, 2022

The Parsons City Council met for its regular monthly meeting, May 2, 2022, at 6:00PM in the city council room. Mayor Tim David Boaz called the meeting to order.

Approval of regular monthly minutes and special called meeting minutes for last month:

Approval of the Financial Statements for the last month:

Community Forum:

Kevin Cagle asked when the splash pad would be open.

The splash pad will be open (with a set hours of operation) daily from Memorial Day to Labor Day.

Joseph Fisher said the park was one of the nicest things the city has ever done. People all over the county are enjoying it. He had a couple of items that he wanted to discuss.

- 1) Round Pillars (gray and yellow) people are running over the gray pillars. They are hard to see at dusk. We may want to consider painting all of them yellow to be more visible to all.
- 2) The Huntingdon Park hosts tournaments. They charge admission for people to enter these events and the city can collect up to \$20,000 per day. This might be something that the City of Parsons would want to consider when we plan for tournaments to come to utilize this potential revenue source.
- 3) We will need more parking to accommodate additional traffic

Communications from the Mayor:

- The sealed pavement at the park will re-striped to fix the crooked lines
- We have two PA's (outdoor speaker sound system) for the park ordered. One came in and one is still on its way
- We are still working on the walking trail. We are looking for someone to make benches out of logs.
- There has been a delivery of concrete blocks at the park these are for the retaining wall on the walking trail
- We will be installing fencing at an open gate of the walking trail with leftover funds, one section at a time, to prevent vehicles from coming in and unloading items at the south end of the runway.
- TCAT Parsons CDL Program is doing very well. Reeves Trucking Company recently hired three drivers from this program. Other local driving companies are recruiting students for placement as well.
- TCAT Parsons LPN Program will be starting soon.
- The traffic light (for the main light) is still in China

• The traffic light at First Baptist is in process of being repaired. The lights were not initially installed properly. The sensors get hit with the afternoon sun that blinds the cameras causing the lights not to change. An extension will be installed to point the camera at a higher angle, that will not be affected by afternoon sun.

Reports from committees, councilmen, and other officers:

CDBG Generator Project (at intake) update from Lee Villaflor:

- The Army Corps of Engineers issued the permit to allow us to go under Beech Bend
- McFall Construction was onsite and will start boring the tunnel for this project
- Wednesday, May 4, 2022 will be the 1st of the 2 advertisements for bids for generator in the paper
- Friday, May 27, 2022 Bid opening at 12:00PM in City Council Room

TDEC - \$3.2M ARPA Funds (Water and Wastewater) update from Lee Villaflor:

- Decatur County Commissioners have not yet voted on this project. Mayor Mike Creasey has given a verbal agreement to Lee Villaflor but it will need to be approved by vote from the county commission to proceed
- City of Parsons will receive \$887,122 from TDEC
- City of Parsons sent Mike Creasey a letter asking for \$662,769 of the \$3.2M county TDEC funds
- City of Parsons will pay for the match \$154,989 and overage \$67,620
- Decatur County would not be required to match funds
- Total Project \$1,772,500
- Approval of this project would provide much needed reliable water service to Scotts Hill and North Utility District
