Approval of the Financial Statements:

Presentations:

Mayor Tim David Boaz and City Administrator Lee Villaflor gave the council an update on current City of Parsons projects.

- CDGB Intake Generator
 - We submitted our bids on the generator for the intake station to the State of TN
 - The State of TN approved our submission
 - We will be having a pre-construction meeting in the next couple of weeks
 - The gas line is ready, the City is ready to start this project

- Sewer Plant
 - We have been struggling with electrical issues (we are at the end of a service line and tend to get surges, blown fuses, power outages, etc)
 - Lexington Electric came last week and raised the voltage by 13-14 volts
 - The Contractor and aeration installer (Triplepoint) recommended better ventilation to in the building
 - We were able to run all weekend with these updates/changes (we will be monitoring weather as heat can be a factor as well)
- Multimodal Grant (East 9th St to Price St)
 - Project has been submitted to TDOT
 - City match is %5
- Red light upgrade (Main Light TN Ave/Main St)
 - Project on hold due to the Contractor (Wade Electric) waiting on a part to proceed with completing this project
- Gas Line Extension Projects
 - South End Gas project 99% complete, waiting on TVA Permit to complete boring, but we are ready to start taking residential gas taps for Hwy 202 area
 - North End Gas project Contractor is working on installing lines on Horny Head Creek Road on the Holladay Rd side. This project is going slower at a rate of 800 ft p/day (as opposed to 3000 ft p/day on the South End project)
- TDEC ARP County Water Project
 - There was a meeting last week with all the water districts and water suppliers in the County
 - Town of Scotts Hill
 - Town of Decaturville
 - North Utility Water District
 - Perryville Utility District
 - City of Parsons
 - Parsons has the best source of water. Scotts Hill is looking at purchasing City of Parsons Water to provide a section (400 customers) of their system to take strain off their two plants that they have
 - North Utility is also looking at purchasing water from the City of Parsons this will only help them with impending growth to the north end of the county.
