ARP Project (Pipe Bursting): Projected start date February 2025

<u>ARP Project (Decaturville drinking water)</u>: ABES Construction company was awarded this project. Pre-Construction meeting this Friday.

<u>TAM (Tennessee Association of Museums Grant (Municipal Building Roof Replacement)</u>: JM Roofing Company was awards this project. The City Council will vote to approve funding to re-roof the rest of the Municipal Building that is not covered by this grant later in this meeting.

TDOT (Multimodal Grant: This project is in review at TDOT

2024 CDBG (Passive Park): This project is in the environmental phase

PHMSA Gas Grant: This project is close to the environmental phase

<u>FEMA (2019 Hazardous Mitigation) Generator Grant</u>: Waiting on FEMA – no new updates. We may send a letter to the President for progress.

City of Parsons intends to apply for the next AFG Safer Grant to add PSO personnel when it opens. The city has also applied to the State of Tn Fire Marshall Grant for equipment. We anticipate award results soon.
